1 Start your journey by identifying your product code

The ASEAN Tariff Finder is an online portal that offers information on customs duties, taxes, additional duties, related Rules of Origin as well as import regulations of more than 160 destination countries worldwide.

All nomenclatures in the ASEAN Tariff Finder are available in English and reflect the currently applied customs tariffs. You may either use product codes based on the Harmonized System (HS), keywords, free texts or the nomenclature tree view to find out trade-related information such as customs duties, Rules of Origin and import regulations of destination countries. Although the first six digits are based on the HS, the classification after the sixth digit may vary according to regional or national particularities.

The ASEAN Tariff Finder offers you information on the Most Favoured Nation (MFN) duty rates, tariff quotas and suspensions, preferential duty rates for goods originating in the ASEAN Member States, as well as additional duties levied at import. Furthermore, it provides for information on turnover taxes such as Value Added Tax (VAT) or sales taxes, excise duties or other taxes and charges levied before goods are released for free circulation.

The ASEAN has concluded several FTAs that are reflected in the ASEAN Tariff Finder. The application of the corresponding ROO may lead to reduced tariff rates or even duty-free access of your product. However, the preferential rates as well as the Product Specific Rules (PSRs) may vary with the different Agreements. For the product codes chosen, the ASEAN Tariff Finder will show the applied tariff rates and relevant PSRs.

Required for customs clearance.

The permit is to be applied for by the importer through the Biosecurity import conditions database (BICON) administrated by the Department of Agriculture, Fisheries and Forestry, GPO Box 858, AU-Canberra ACT 2601, phone number: +61 2 62723933.
